1. Secretary - Melinda

Nicole made a motion to approve the January 2nd minutes with the adjustments made. The motion was second by Caryn. The motion passed unanimously.

2. Treasurer - Morgan

The check register, Investors Advantage register, income statement and balance sheet were reviewed. The dissolved UP Chapter funds were transferred to the WDCTA account. The Eastern Chapter funds were transferred to the chapter's new bank account.

The Berkley Equine liability insurance was paid. It was noted that it is necessary when holding a show or clinic to let the liability insurance know the dates of the event.

A motion was made by Donna to move the money in the coming maturity of the 7-month certificate to a higher rate 14-month certificate. The motion was second by Mary and then passed unanimously. Morgan will work on making the transfer.
